

**ORDINANCE NO 2007-01**  
**AN ORDINANCE FOR THE REGULATION OF OFF-  
HIGHWAY VEHICLES**

**AN ORDINANCE OF THE TOWN OF SILVERTON, COLORADO, ADOPTING BY REFERENCE SECTIONS 104, 108, 109, 111 AND 113 OF ARTICLE 14.5, TITLE 33 OF THE COLORADO REVISED STATUTES REGULATING THE USE OF OFF-HIGHWAY VEHICLES IN THE TOWN OF SILVERTON AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.**

BE IT ORDAINED BY THE TOWN COUNCIL, TOWN BOARD OF TRUSTEES OF SILVERTON, COLORADO, THAT:

Pursuant to Section 202 of Article 16, Title 31 and Section 41 of Article 15, Title 31 of the Colorado Revised Statutes, there is hereby adopted by reference by the Town of Silverton Sections 104, 108, 109, 111 and 113 of Article 14.5, Title 33 of the Colorado Revised Statutes.

Sections 104, 108, 109, 111 and 113 of Article 14.5, Title 33 of the C.R.S. regulate the operation of off-highway vehicles upon public roads and lands of the state of Colorado, including the public roads and lands located in the Town of Silverton. The purpose of adopting this Ordinance is to provide a set of off-highway vehicle regulations for the Town that are consistent with state law and conform to similar regulations throughout the state. A copy of the C.R.S. sections adopted herein is filed in the office of the Town Clerk of the Town of Silverton and may be inspected during regular business hours.

It is hereby declared to be unlawful for any person to violate any of the provisions set forth in this ordinance, and any person so violating those provisions shall be subject to the penalties set forth below. This ordinance shall apply to every street, alley, sidewalk area, driveway, park and every other public way, place or parking area either within the corporate limits of the Town of Silverton, or in any area outside of the Town limits in which the Town has jurisdiction.

Any person who violates any section of this ordinance shall be subject to a penalty in the form of a fine not to exceed \$ 75.00

If any part or parts of this ordinance are for any reasons held to be invalid such decisions shall not affect the validity of the remaining portions of this ordinance. The Town Board hereby declares that it would have passed this ordinance and each part or parts thereof, irrespective of the fact that any one part or parts be declared invalid.

This ordinance shall be so interpreted and construed as to effectuate its general purpose to conform with the State's uniform system for the regulation of off-highway traffic. Article and section headings of the ordinance shall not be deemed to govern, limit,


modify or in any manner affect the scope, meaning or extent of the provisions of any article or section thereof.

This ordinance shall repeal existing ordinances or parts of ordinances covering the same matters as embraced in this ordinance and all ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.

The Town Clerk shall certify to the passage of the ordinance and make not less than three copies of the adopted code available for inspection by the public during regular business hours.
