# SPECIFYING WEIGHT LIMITS FOR VEHICLES

#### **9-2-1: Authority**

The Town of Westcliffe has the power to regulate the weight of vehicles allowed on public streets pursuant to the Model Traffic Code, Section 106{3} (Ord. 1-2007, eff. 10-4-2007)

#### **9-2-2: Use of vehicles**

- a. Hermit Lane                      that the use of vehicles on Hermit Lane in Westcliffe, Colorado, from Hermit Road northeast to the Silver Cliff Town limit, shall be restricted on commercial vehicles having a Gross Vehicle Weight Rating (GVWR) of more than 10,000 {ten-thousand} pounds, excluding local deliveries. (Ord. 1-2007, eff. 10-4-2007)
- b. Second Street                      that the use of vehicles on Second Street in Westcliffe, Colorado, from Rosita Avenue south to Hermit Road, shall be restricted on commercial vehicles having a Gross Vehicle Weight Rating (GVWR) of more than 10,000 {ten-thousand} pounds, excluding local deliveries. (Ord. 1-2007, eff. 10-4-2007)
- c. Third Street                      that the use of vehicles on Third Street in Westcliffe, Colorado, from Rosita Avenue south to Hermit Road, shall be restricted on commercial vehicles having a Gross Vehicle Weight Rating (GVWR) of more than 10,000 (ten-thousand) pounds, excluding local deliveries. (Ord. 1-2007, eff. 10-4-2007)
- d. Adams Boulevard                      that the use of vehicles on Adams Boulevard in Westcliffe, Colorado, from Rosita Avenue south to Powell Avenue, shall be restricted on commercial vehicles having a Gross Vehicle Weight Rating

(GVWR) of more than 10,000 {ten-thousand} pounds, excluding local deliveries. (Ord. 1-2007, eff. 10-4-2007)

e. Powell Avenue

that the use of vehicles on Powell Avenue in Westcliffe, Colorado, from Adams Boulevard east to Third Street, shall be restricted on commercial vehicles having a Gross Vehicle Weight Rating (GVWR) of more than 10,000 (ten-thousand) pounds, excluding local deliveries. (Ord. 1-2007, eff. 10-4-2007)

**9-2-3: Enforcement**

In order to enforce the provisions of this section, the Town shall provide and post signs in locations as are visible to provide notice to motorists of this weight restriction and penalties for violations of this ordinance shall be in accordance with the Town of Westcliffe Code of Ordinances, Title 9, section 9-1-2.
