Purpose and Audience:

The purpose of this Informational Memo is to inform county departments of human/social services and local public health agencies of the opportunity to participate in Department listening sessions regarding implementation of the Accountable Care Collaborative (ACC) Phase II.

Information:

The Department will be hosting **optional** listening sessions based on pre- and post-implementation activities for ACC Phase II. These listening sessions will be based on different topics: Member Correspondence and Feedback, Member Feedback and Issues and Provider Feedback and Issues. Information shared from counties during the listening sessions will be collected and shared with the ACC Phase II Command Center, manned by Department staff in regular communication with the Regional Accountable Entities (RAEs), Health First Colorado Member Contact Center, DXC Technologies, Health First Colorado Enrollment, and outgoing contractors.

County partners should call into the listening session type that best fits the information that's needed or based on the type of feedback the Department is gathering during the session:

Member Correspondence and Member Feedback listening sessions – these listening sessions are designed to share information/resources available for counties;

review member correspondence sent; answer outstanding questions counties have received and documented from members and capture any member feedback counties have received. The Launch Support listening session on June 27, 2018 will provide further information on available support and resources for the July 1, 2018 implementation date.
