Purpose and Audience:

The Colorado Department of Health Care Policy and Financing invites the public to comment on proposed waiver amendments to the following Home and Community Based Services (HCBS) waivers: Children's Extensive Support (CES), Persons with Developmental Disabilities (DD), and Supported Living Services (SLS).

Information:

The Department intends to submit the amendments to the Centers for Medicare and Medicaid Services (CMS) on October 1st, 2018. The Department will request an effective date of January 1st, 2019 for all amendments.

The proposed waiver amendments include the following changes:

- Addition of Transition Services (DD, SLS)
- Update to Case Manager (CM)/Case Management Agency (CMA) Qualification Criteria (CES, DD, SLS)
- Home Modification Update to Durable Medical Equipment (DME) (CES, SLS)
- An increase to the Service Spending Limits (CES)
- Addition of Post Payment Review Performance Measure (CES, DD, SLS)
- Addition of the Prader-Willi diagnosis to the Development Disability Definition (CES, DD, SLS)
- Update to language to remove references to Dear Administrators Letters (DAL) and replace with the Department's Memo Series (CES, DD, SLS)
