Purpose and Audience:

The Colorado Department of Health Care Policy and Financing invites the public to comment on the proposed waiver amendments to the following Home and Community Based Services (HCBS) waivers: Persons with Brain Injury (BI), Children's Home and Community Based Services (CHCBS), Children with a Life-Limiting Illness (CLLI), Community Mental Health Supports (CMHS), Persons who are Elderly, Blind and Disabled (EBD), and Persons with Spinal Cord Injury (SCI).

Information:

The Department intends to submit the amendments to the Center for Medicare and Medicaid Services (CMS) on October 15th, 2018. The Department will request an effective date of January 1st, 2019 for these amendments.

The proposed waiver amendments include the following changes:

- Community Choice Transition (CCT)- New Services (BI, CMHS, EBD, SCI)
- Case Manager (CM)/Case Management Agency (CMA) Qualification Criteria (BI, CHCBS, CLLI, CMHS, EBD, SCI)
- Home Modification Update to Durable Medical Equipment (DME) (CMHS, SCI)
- Post Payment Review (BI, CHCBS, CLLI, CMHS, EBD, SCI)
- Replacement of Dear Administrators Letter (DAL) language (BI, CHCBS, CLLI, CMHS, EBD, SCI)
- Adult Day language update (CMHS, EBD, SCI)
- Consolidated Reporting (CMHS)
- Quality Improvement Organization (QIO) Activities language including adding

- Performance Measures (PM) (CMHS, SCI)
- Public Conveyance addition to Non-Medical Transportation and adding a contracted Administrative Services Organization (ASO) Performance Measure (PM) to monitor the contracted entity (BI, CMHS, EBD, SCI)
- Reserved Capacity removal (BI)
- SLP Rate Acuity Tool (BI)
- Respite Service Update (CLLI)
