Purpose and Audience:

The Colorado Department of Health Care Policy & Financing (Department) invites the public to comment on proposed waiver amendments for the following Home- and Community-Based Services (HCBS) waivers: Persons with Brain Injury (BI), Children's Home- and Community-Based Services (CHCBS), Children with a Life-Limiting Illness (CLLI), Community Mental Health Supports (CMHS), Persons who are Elderly, Blind and Disabled (EBD), and Persons with a Spinal Cord Injury (SCI).

Information:

The Department intends to submit the amendments to the Centers for Medicare and Medicaid Services (CMS) on April 2, 2019. The Department will request an effective date of June 30, 2019 for these amendments.

The proposed waiver amendments include the following changes:

- Update language related to the Post Payment Review (PPR) Function and Oversight (BI, CHCBS, CLLI, CMHS, EBD, SCI)
- Update Performance Measures for multiple Quality Improvement Strategies sections (BI, CHCBS, CLLI, CMHS, EBD, SCI)
- Update the Supported Living Program (SLP) rate methodology (BI)
- Update Cost Neutrality Projections (BI CHCBS, CLLI, CMHS, EBD, SCI)
