The Department's Appeals Navigation Process is designed to support members through the appeals process. The Appeals Navigator helps members navigate the appeals process and answers questions that they may have about their appeal including; the reason for their appeal, what to expect during the appeal and administrative hearing, legal resources, continuation of benefits, information and referral, and next steps. Members, guardians, and advocates can learn more by attending an information session in Denver or Colorado Springs, or via webinar. The information sessions will outline:

- Departmental staff roles in the appeals process;
- What to expect in the Appeals Navigation Process;
- Potential steps to resolve an appeal prior to hearing; and
- Information to help prepare for a hearing.
