### **Purpose and Audience:**

The purpose of this Operational Memo is to inform Case Management Agencies of operational instructions related to the licensure suspension of the following Home Care Agencies: Center Home Health Services Inc., Center Home Health Care, Genesis Home Care, and Center Home Care Inc. of the Rockies.

#### **Background:**

The following Home Care Agencies have been notified of suspension of licensure with the Colorado Department of Public Health and Environment (CDPHE) effective August 7, 2018:

Center Home Health Services Inc. 04D457 Class B, HCA-PHS, IHSS (Fort Lupton)

Center Home Health Care 04I961 Class A (Fort Lupton)

Genesis Home Care 10047G Class B, HCA-PHS (Wheat Ridge)

Center Home Care Inc. of the Rockies 04E906, Class B, HCA-PHS (Greeley)

Following suspension of licensure, agencies are not authorized to provide licensed services in the State of Colorado. Please be advised that clients of the above agencies will no longer have services with said agencies effective August 7, 2018.

### **Information/Procedure:**

Case Managers must contact all current clients of the above agencies and transition to another licensed Home Care Agency immediately. Case Managers must provide a transition update to CDPHE including: client name and state ID, date of transition, and new agency information.
