Qualitrac Basics



Qualitrac is the proprietary web-based portal used and maintained by Telligen's IT department



- Step-by-step instructions through relevant modules
- Automation that streamlines review process with real time notifications
- Secure electronic upload of medical records
- Allows providers to track progress of submitted requests
- 24/7 access
- User friendly

Qualitrac Basics (cont.)



Provider portal registration and creating accounts

- The Provider Portal Registration Process is completed entirely online in 3 easy steps:
 - The **Provider Executive** i.e. the duly authorized representative permitted to bind your organization, agrees to the terms and conditions of the Provider Portal Agreement.
 - The Provider Executive designates one or more Authorized Officials for your organization. These individuals will manage provider accounts within your organization.
 - The Authorized Official(s) complete the Authorized Official Agreement and Registration form.
- The Qualitrac Registration team at Telligen will then complete the registration process and provide further instructions to the Authorized Official.
- The online forms leverage DocuSign technology and will be routed via email to appropriate parties for signature, returning full executed agreements to the Provider Executive and the Authorized Official(s)

- PASRR is a person-centered process to provide an objective clinical assessment for folks that could potentially benefit from additional services at the nursing home level of care, specific to addressing an intellectual or mental health disability.
- PASRR has been around for over 3 decades and continues to maintain relevance and provide benefit for individuals, as evidence by continued resources through PTAC and a new notice of proposed rule making.
- PASRR is a clinical opportunity and not paperwork compliance requirement.
